Smith Roofing and Siding, L.L.C. (Smith Roofing) is the most recent iteration of a family owned business that has operated in Southeast Idaho for over fifty years across multiple generations and it is not, nor has it ever been, affiliated in any way with Glendon Ashley Smith (Glen Smith). On June 16, 2025, the arrest of Glen Smith was reported and he was identified as the owner of Smith Roofing LLC. Glen Smith's entity was organized on December 22, 2021, after Smith Roofing had been in business for over 50 years, and it has since been administratively dissolved by the Idaho Secretary of State. Judgment has been entered against Glen Smith and his entity by the United States District Court for the District of Idaho, Judge David C. Nye presiding, that prohibits Glen Smith and his entity from using the name "Smith Roofing" or any other name or trademark that would suggest any affiliation with Smith Roofing.

Since at least the early 1970s, Smith Roofing has consistently used the tradenames "Smith Roofing" and "Smith Roofing Company." In late 2021, Glen Smith organized his entity and began doing business as Smith Roofing. In addition to using the same trade name, Glen Smith adopted a stylized trademark that mimicked the trademark used by Smith Roofing since 2008. Glen Smith also established multiple websites marketing the same services as Smith Roofing in the same geographic area.

On June 30, 2023, Smith Roofing filed Case No. 4:23-cv-00310-DCN in United States District Court against Glen Smith and his entity alleging, among other claims, trademark infringement and unfair competition. On March 26, 2024, Judge Nye entered an order finding that Glen Smith and his entity, "Through intentionally using an identical trade name and confusingly similar mark, . . . have diluted Plaintiff's reputation and good will." On April 4, 2024, Judge Nye entered Judgment against Glen Smith and his entity prohibiting their use of the name "Smith Roofing," prohibiting their use of any trademark similar to the trademark of Smith Roofing, requiring Glen Smith to change the name of his entity to a name that does not use the words "Smith Roofing", and awarding Smith Roofing attorney fees and costs.

Notwithstanding the Court's judgment, Glen Smith failed to change the name of his entity and continued using the name "Smith Roofing" in violation of the Court's judgment. On March 22, 2025, Smith Roofing asked the Court to sanction Glen Smith and his entity for their violations of the judgment. On May 6, 2025, the Court found Glen Smith in contempt of court for his continued use of Smith Roofing's name. Glen Smith has no legal right to use the name "Smith Roofing" in the Southeast Idaho community.
